

Privacy policy as per articles 13-14 of the GDPR 2016/679 (General Data Protection Regulation)

Dear Sir/Madam,

according to article 13 of Law decree 196/2003 (hereinafter "Privacy Code) and articles 13-14 of EC rules no. 2016/679 (hereinafter "GDPR 2016/679") that gives the provisions relevant to the protection of personal details of individuals and other subjects, we want to inform you that the personal data that you provide will be processed by **Associazione Amici del Carnevale di Venezia** in accordance with the above-mentioned regulation and the confidentiality obligations.

In order to protect the personal data of individuals and other subjects, we inform you about the following:

1. Data Holder

The data holder is Associazione Amici del Carnevale di Venezia with registered office in: Venezia, via Vivaldi no. 6, CAP 30161. For further information and communications relevant to the processing of data, please write to amicicarnevalevenezia@gmail.com

2. Processed data

The website of Associazione Amici del Carnevale di Venezia (www.amicicarnevalevenezia.net) can be accessible without the need to provide any personal details, but the Associazione Amici del Carnevale di Venezia may collect the following data:

- Personal data (name, surname, age and genre)
- Personal documents (fiscal code, passport and/or identity card)
- Address or residence and other details such as telephone and email address.

This data is provided by the user as follows:

- By completing online forms from the website Associazione Amici del Carnevale di Venezia
- By filling out paper forms handed to the Associazione Amici del Carnevale di Venezia when historical events or parties and festivals take place. These forms indicate the purpose of processing the personal data and the user's consent is required.
- By contacting the Association secretary's office (either by phone or email)
- The users will provide their personal details only after reading this privacy policy statement.

3. Purposes of the processing

The personal data are collected by the Associazione Amici del Carnevale di Venezia for organizing activities as well as for sending cultural or promotional communications relevant to the activities and events promoted by Associazione Amici del Carnevale di Venezia.

4. Providing personal data

It is compulsory to provide personal data for the purposes given in paragraph 3; the refusal to provide them will cause the disqualification of the person as a member of the Association.

5. Communication and diffusion of data

The personal data collected by the association won't be communicated or diffused.

6. Rights to check, cancel, limit and transfer the personal data

The Associazione Amici del Carnevale di Venezia would like you to know that members are entitled to the rights given in articles from 15 to 20 of the GDPR. Therefore, as an example, by sending an email to amicicarnevalevenezia@gmail.com, you will be able to do the following:

- a) request a confirmation of the existence of your personal data;
- b) get information about the purposes of the processing of personal data, the categories of personal data, the persons or the categories of persons to whom your personal data have been communicated or will be communicated;
- c) correct your personal data and have your personal details cancelled if one of the conditions given in article 17 of the GDPR can be enforced;
- d) limit the processing of your personal details in the event one that cases given in article 18 of the GDPR are met;
- e) have your data transferred or receive it from the holder of the processing in a standard format readable by an electronic device and ask that the data are transmitted to another holder, if this operation is technically possible;
- f) refuse that your personal details are processed at any time
- g) withdraw the consent of processing the data without prejudicing the legacy of the data processing that was given before your withdrawal;
- j) place a claim with an Authority such as the Data Protection Supervisor, according to the methods given on the website www.garanteprivacy.it

7. Preservation

Your personal data will be kept for the time necessary to achieve the purposes for which they are collected and processed. You can exert your rights by sending an email to amicicarnevalevenezia@gmail.com or to the address of the registered office.
